2020 Jr. Livestock Sale Policy

1. All buyers must register on the EZ2Bid.com website. Once registered, buyers will be able to bid on any animal for the duration of the 2020 Amador Quarantine Classic Jr. Livestock Sale.
2. All animals will be sold by lot, not by pound.
3. There is no 7% commission per lot assessed on the exhibitors. Exhibitors will be responsible for any related show/sale costs not covered by donations and sponsorships.
4. Buyers will be able to ask for a proxy bidder. Contact the Fair office if interested.
5. Buyers will be able to enter a "max bid" (like eBay). This will allow the buyer to enter the maximum amount willing to pay for any individual animal.
6. All buyers are expected to pay for their purchases on the day of the Sale. Cash, Check, Visa, MasterCard, Discover and American Express are accepted forms of payment. Billing is not allowed *without prior approval from the Fair*. An additional fee of \$35 shall be assessed on all insufficient fund checks and/or transactions fees resulting from a declined check or credit card transaction. A 3% convenience fee will be added to each transaction to cover any bank fees incurred by the sale.
7. All auction transactions will be conducted through, and payment made to the Amador County Fair JLA. It is the responsibility of the buyer to ensure all outstanding balances are paid. Should the animal(s) not be paid the day of the sale, at 30 days, any outstanding balances and fees will accrue a twenty percent (20%) penalty, compounded monthly, until the balance is paid in full.
8. Add-On's will be available for buyers to add a flat rate to an exhibitors (sellers) lot. A buyer's name and EZ2Bid bidder number is required to give an add-on and payment will adhere 6 and 7. Contact the Fair office to apply add-on's. Add-ons will be accepted through Sunday the 26th at 3 pm.

The sale is terminal for all market animals. Replacement Heifers sold will be picked up or delivered (arrangements made between buyer and seller). ALL market animals sold through the 2020 Amador Quarantine Classic Sale on EZ2Bid.com will be transported to the USDA approved processing facility. After purchase of animal, you must indicate disposition of the animal. There are two choices:

Custom Harvest and Return – the animal will be processed and delivered to the custom cut and wrap facility indicated on the sales invoice. A harvest charge will be included in your sales invoice. Large Animals will go to Kountry Meats in Elk Grove and Small Animals to Archer's Butcher Block in Placerville.

Resale – if an animal is bought to support an exhibitor or the auction, the harvester will accept and sell animal at market prices at a later date. The buyer is billed for the difference between the current market price per pound and the sale price the day of the sale. A harvest charge will be included in your sales invoice. The resale prices will be listed on the EZ2Bid.com 2020 Amador Quarantine Classic Sale page when the sale begins on the 24th.
