CONDITIONS OF SALE AGREEMENT

Please read the Conditions of Sale agreement before signing. You have agreed to the terms and conditions that will be enforced for you, your business/organization and/or, if you are acting as the agent for another individual, business or organization.

By signing below, you (buyer) enter a contract with the Amador County Fair, with the following conditions for the sale:

1. The 2020 Amador Quarantine Classic Jr. Livestock Sale is a Hybrid Sale. Replacement Heifers will be sold as production animals. All other animals sold through this sale (market beef, sheep, goats, swine, turkeys, rabbits and chickens) are terminal. All market animals purchased have the option of custom harvest or resale.
2. All market animals sold through this sale will be transported to a United States Department of Agriculture approved processing facility contracted with the Amador County Fair. Transportation will be provided by the fair. The split carcass (except for resale animals) will be returned to the cut and wrap facility offered by the Amador County Fair.
3. Arrangements will be made between the exhibitor (seller) and buyer for delivery of replacements heifers after the conclusion of the sale.
4. All buyers will be required to provide credit card information or other guaranteed form of payment (signed check) to the fair unless approved otherwise prior to the sale.
5. I understand and agree that purchases made at the Amador County Fair JLA are considered due and payable on the day of the sale. Should the balance not be paid in full the day of, all monies must be received within 30 days of the sale. At 30 days, all outstanding balances and fees will accrue a twenty (20%) percent penalty, compounded monthly, until the balance is paid in full.
6. Acceptable forms of payment are cash, check, Visa, MasterCard, Discover and American Express. An additional fee of \$35 is agreed to by the buyer on all insufficient fund checks and/or transaction fees resulting from declined check or credit card transaction.
7. ***Amador County JLA exhibitors (sellers) will not receive payment until enough monies are received to distribute all exhibitor (seller) checks.***
