 - (1) Pre-Weigh: No minimum, max weight 180lbs
 - (2) Fair Weigh In: Minimum 220lbs, Max weight 280lb. 20% rate of gain requirement.
 - b) Lambs:**
 - (1) Pre-Weigh: No minimum, no maximum
 - (2) Fair Weigh In: Minimum 100lbs, no maximum weight, 155lbs max payout. 20% rate of gain requirement.
 - c) Goats:**
 - (1) Pre-Weigh: No minimum, no maximum
 - (2) Fair Weigh In: Minimum 65 lbs, no maximum. 105lbs max payout. 20% rate of gain requirement.
