The Fair is taking the following applications for the 2019 Amador County Fair:
Guest Services (formally known as Security), **Maintenance:**

Must apply in person to the Fair's Administration Office at 18621 Sherwood & School Streets, Plymouth, CA 95669. Office hours are: Monday through Friday - 9 am to 4 pm. Must have a valid Driver's License or ID card, Social Security Card or 2 legal forms of ID to meet hiring regulations. Should be 18 years or older.

Shifts: Morning, Afternoon, Evening & Night.

Salary: Minimum wage. All earned hours are paid at straight time, no overtime is paid.

Who should apply? The Fair is looking for people who like people!! Be reliable and show up for your assigned shifts on time. Need to enjoy being outdoors. Must have a neat and clean appearance. Be able to stand/walk for 2 hours at a time depending on the post/position you are assigned. Have to be able to pick up 20 – 50 lbs.

As a temporary employee of the fair, you will want to be polite, friendly and be ready to greet our guests with a smile. Patiently answer/listen to questions and concerns, of all sorts, in an attentive, friendly manner. Work well with others. Take directions from a Supervisor.

DESCRIPTIONS:

Guest Services (Security) Post Descriptions - Shifts are 6 to 8 hrs

CARNIVAL GATE: ("YELLOW GATE") located behind the carnival and off of "Sherwood St."
Carnival workers & Entertainers only admitted through this gate

PARKING LOT ACROSS FROM CARNIVAL GATE: This lot is for overflow Entertainer parking and on Sat night, for Rodeo participants **Only**. There should not be any people standing, (partying) in this area at any time. The Carnival Gate attendant can oversee this lot.

BACK TICKET GATE: Patrons with tickets/passes only. Have a hand-stamp to stamp peoples hands if they are returning that day. (We use a different stamp each day). Scanning on-line tickets.

FRONT GATE: Patrons with tickets only. Have a hand-stamp to stamp peoples hands if they are returning that day. (We use a different stamp each day). Scanning on-line tickets.

LIVESTOCK BRIDGE: Keep the area clear of vehicles.

OVER FLOW PARKING: This is the area to the south of the camping area used for trailer parking. No camping is allowed in this area, only parking. The vehicles should have a "Livestock Parking" or "Horse Show" hanging tag in their vehicle. Trailers usually do not have a tag. Making sure that vehicles park in an orderly manner and do not block anyone or the gate.

LIVESTOCK DRIVE THROUGH GATE: (BLUE GATE) This gate is used for Livestock Exhibitors, Horse Show Exhibitors and Arena Event personnel, Delivery, possibly Entertainers and Officials can also enter this gate. **THIS IS NOT A WALK THRU GATE.** People walking must go over through the Log Cabin ticket entrance. Vehicles must stop and show their passes. They must have a vehicle pass AND people gate passes. On Sunday large Livestock trucks will come in and they have no pass, but are here to pick up livestock from the auction, please let them in. Garbage, Portable outhouse cleaning trucks may also use this entrance. Use common sense as to who is allowed through (fire, police, ambulance, maintenance etc.) ANY QUESTIONS, use your RADIO and call.

BARN ROVER: To patrol barns and surrounding areas. Animals should be in there pens and the public should not be! Animals are not allowed in camping or other areas outside of the barns.

EAST HS BARN PARKING: This area is to be kept for single day horse show exhibitors during the day. Fri, Sat & Sun will have Arena Event participants in this area too.

OFFICIAL PARKING Road: This is the street that leads from Main St. to the front of the Admin and Entry Offices. Only people with "OFFICIAL PARKING" passes are allowed in this area. Only exceptions are emergency vehicles/personnel. CALL if you have any questions.

GAS ENGINE GATE – ROAD: This is the entrance off of Main St./Old Sac Rd. designated for the gas engine exhibitors (they will have a membership card or pass.) The Floriculture staff & exhibitors, Sawmill, Goldmine and Rail Road people will use this entrance also. They should have Fair passes.
Use common sense as to who is allowed through (fire, police, ambulance, maintenance etc.) ANY QUESTIONS, use your RADIO and call.

GAS ENGINE GATE – INSIDE: This is the entrance off of Main St./Old Sac Rd. designated for the gas engine exhibitors (they will have a membership card or pass.) The Floriculture staff & exhibitors, Sawmill, Goldmine and Rail Road people will use this entrance also. They should have Fair passes or badges.
Use common sense as to who is allowed through (fire, police, ambulance, maintenance etc.)

Grounds & Buildings Rover: Areas assigned by Supervisor.

Shifts are 6 to 8 hrs

MAINTENANCE: Assist the Head of Maintenance. This could be repairing, replacing, painting, cleaning, lifting, putting up signs/banner/flags, etc. Must be able to lift a minimum of #50. Have a valid driver's license and ID.

RESTROOM ATTENDANTS: Checking, Cleaning and Re-Stocking all restrooms throughout the fairgrounds. (Behind BANDSTAND, in BANDSTAND, HANDICAP SHOWERS, ARENA, MIDWAY, PRIVY, SPUR, HORSE SHOW AND PORTABLE SHOWER UNITS -2, FIRST AID AND ADMIN OFFICE.)

PARKING ATTENDANTS: Must be able to stand at least 4 hrs. Must have a friendly and positive attitude. (You are the first person our patrons see, so it is your job is to park them safely and keep them smiling! The parking lots are mostly dirt, so comfortable shoes and neat clean clothes are a must. Don't forget sunscreen and a hat.
